This field trial will be held under rules and procedures of the American Kennel Club and the Dachshund Club of America, Inc.

Entries for all stakes will close and bracing will take place at **7:30 am** local time. Dogs must be present on the grounds when entries close to be officially entered. Be sure you have all the information you need to complete the entry forms. Entry forms are attached and also will be available at the trial.

Field Trial Entry Fees
\$25 per dog per stake entered
\$10 per dog per stake for junior handlers

Dachshund Field Trail Rule Book: Chapter 7, SECTION 11. No Special Inducements. A field trial-giving club shall not accept an entry fee other than that published in its premium list or entry form, or in any way discriminate between entrants. No club or member of any club shall give or offer to give any owner or handler any special inducements, such as reduced entry fees, rebates, allowances for expenses or other incentive of value for a certain number of entries. Except a club, at its discretion, may allow for a reduced entry fee for dogs handled by juniors. The reduced entry fee may only apply to specific stakes or may apply to any stake in the trial. The reduced entry fee shall be published in the premium list. A junior is defined as someone less than 18 years of age on the first day of the event. The junior must handle the dog in the event to qualify for the reduced entry fee. If the dog is entered under this provision but the junior does not handle the dog, the owner must pay the regular entry fee as published.

Absolute is a competition held for the winners of all regular classes at an AKC licensed or member dachshund field trial. It may be awarded at any field trial that offers both Open All Age and Field Champion stakes. The running procedure for Absolute shall be at the discretion of the field trial committee and shall be specified in the premium list. Bitches that are in season, as determined by the field trial committee, are ineligible for Absolute if there are any male class winners competing. Absolute may be withheld for lack of merit but not for lack of competition. The AKC criteria for eligibility to judge is defined in "Field Trial Rules and Standard Procedure for Dachshunds," Chapter 5, and shall be applied to the selection of judges for Absolute. The judges for Absolute may either be advertised in the premium list or selected the day of the trial by the field trial committee. (10/2017) (B)

GPS/Tracking/Correction Collars are not permitted at BRVDC AKC events.

The field trial committee reserves the right to alter the running order in any manner to expedite the trial.

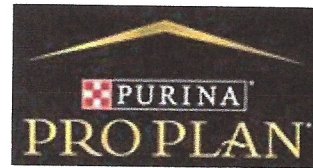

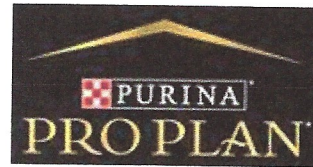
